in 2016-Q2 to 98,495 active listings. Texas homes also continued to spend less time on the market, averaging 54 days, which is one day less compared to the same quarter of 2015.

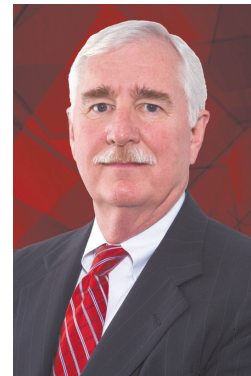
Chairman Smith concluded, "The Texas Association of Realtors continues to advocate for policies that make homeownership more affordable and attainable for more Texans. Most recently, TAR partnered with the National Association of Realtors to support the Housing Opportunity Through Modernization Act as it gained unanimous support in Congress. Nearly

14,000 Texas realtors helped move this important legislation forward to provide more affordable options for Texas homebuyers."

Data for the Texas Quarterly Housing Report is provided by the Data Relevance Project, a partnership among local realtor associations and their multiple listing services, the Real Estate Center at Texas A&M University, and the Texas Association of Realtors. The report provides quarterly real estate sales data from a statewide perspective and for 25 metropolitan statistical areas in Texas. It is sched-
